

AMERICAN FITTINGS Corporation, Limited Product Warranty

AMERICAN FITTINGS sells products with the understanding that the user will perform all necessary tests to determine the suitability of this product for the user's intended application, and warrants to the original purchaser that this product will be free from defects in material and workmanship for the useful life of the product or for three (3) years from the date of purchase, whichever is earlier.

AMERICAN FITTINGS ("AMFICO") WARRANTS TO AMFICO'S CUSTOMER THE PRODUCT BEING SOLD TO THE CUSTOMER AS BEING FREE FROM MANUFACTURING AND MATERIAL DEFECTS FOR THE PERIOD OF ONE (1) YEAR FROM THE DATE OF DELIVERY OF THE PRODUCT TO THE CUSTOMER. AMFICO SHALL HAVE THE RIGHT TO REPLACE OR REPAIR SAID PRODUCT, AT AMFICO'S OPTION, UPON RETURN OF SAME BY CUSTOMER TO AMFICO WITHIN SAID ONE (1) YEAR PERIOD. THIS LIMITED WARRANTY SHALL NOT, HOWEVER, APPLY WHERE THE PRODUCT HAS BEEN MODIFIED, DAMAGED, NOT INSTALLED OR USED IN A PROPER OR LEGAL MANNER OR INSTALLED OR USED IN A MANNER CONTRARY TO AMFICO'S INSTRUCTIONS. CUSTOMER SHALL BE SOLELY RESPONSIBLE TO DETERMINE THE SUITABILITY OF THE PRODUCT FOR CUSTOMER'S INTENDED USE.

AMERICAN FITTINGS warrants to each original Buyer of Products that Products are, at the time of delivery to the Buyer, in good working order and conform to Seller's official published specifications, provided that no warranty is made with respect to any Products, component parts, or accessories manufactured by others but supplied by Seller.

Subject to the limitations set forth below, AMERICAN FITTINGS Corporation will repair or replace, at its sole option, any product that proves to be defective under normal installation, use, and service. AMERICAN FITTINGS reserves the right to replace any warranted product with a substitute product of similar function if the warranted product is no longer available. Installation, operation or use of the product for which this warranty is issued shall constitute acceptance of the terms hereof.

This warranty is void if the product has been subjected to misuse, neglect, accident, fire, flood, physical damage, improper installation, unauthorized modification, or use in violation of our instructions or any applicable laws, codes or ordinances.

ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE DISCLAIMED TO THE EXTENT ALLOWED BY LAW. ANY IMPLIED WARRANTIES THAT CANNOT BE DISCLAIMED ARE LIMITED IN DURATION TO A TERM OF TWELVE (12) MONTHS FROM THE DATE OF PURCHASE. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

PRODUCT ACCEPTANCE

Acceptance shall occur, if not before, when Buyer fails to reject within TWENTY (20) days after delivery of the Products. Buyer may rightfully reject only when a reasonable inspection shows that the Products fail to conform substantially to the specifications for the Products. Buyer waives any right to revoke acceptance. Buyer's remedies for any nonconformity detected after acceptance are limited to those expressly provided in these terms and conditions for breach of warranty.
